BOND RESOLUTION (SUBJECT TO MANDATORY REFERENDUM)

BOND RESOLUTION DATED AUGUST 31, 2021.

A RESOLUTION AUTHORIZING, SUBJECT TO MANDATORY REFERENDUM, THE IMPROVEMENTS TO THE FIRE STATION ON MAIN STREET, IN AND FOR THE VILLAGE OF OXFORD, CHENANGO COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$2,800,000 AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$2,370,000 SERIAL BONDS OF SAID VILLAGE TO PAY A PORTION OF THE COST THEREOF.

WHEREAS all conditions precedent to the financing of the capital project hereinafter described, including compliance with the provisions of the State Environmental Quality Review Act, have been performed; and

WHEREAS the capital project hereinafter described has been determined to be an Unlisted Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed, it has been determined will not result in any significant adverse environmental impact; and

WHEREAS it is now desired to authorize such capital project and its financing; NOW, THEREFORE, BE IT

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the Board of Trustees of the Village of Oxford, Chenango County, New York, as follows:

<u>Section 1.</u> Improvements to the Fire Station on Main Street, including original furnishing, equipment, machinery, apparatus, appurtenances, site improvements, and incidental improvements and expenses, in connection therewith, are hereby authorized, subject to mandatory referendum, at a maximum estimated cost of \$2,800,000, said improvements to include reconstruction and renovation to the existing fire station and construction of an addition thereto.

<u>Section 2</u>. The plan for the financing of the aforesaid maximum estimated cost is as follows:

- a) by the expenditure of \$430,000 fire department building reserve fund monies, which expenditure is hereby authorized therefor; and
- b) by the issuance of not to exceed \$2,370,000 serial bonds of said Village, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is twenty-five years, pursuant to subdivision 12(a) of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

Section 4. The faith and credit of said Village of Oxford, Chenango County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Village, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Village Treasurer, the chief fiscal officer. Such notes shall be of such terms, form, and contents, and shall be sold in such manner, as may be prescribed by said Village Treasurer, consistent with the provisions of the Local Finance Law.

Section 6. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities, and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Village Treasurer, the chief fiscal officer of such Village. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Village Treasurer shall determine consistent with the provisions of the Local Finance Law.

Section 7. The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- 3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 8. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 9. Upon this resolution taking effect, the same shall be published in summary form in the official newspaper of said Village for such purpose, together with a notice of the Village Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

<u>Section 10.</u> Pursuant to the provisions of Section 36.00 of the Local Finance Law, this resolution is adopted subject to mandatory referendum upon the Board's own motion.

Physicals are coming up. All testing has been completed. Truck 261 cannot be inspected per NYS Dot due to the springs. This truck is parked at the back of station now. There is an expense this year for hydrotested and this must be done every 5 years.

EMS REPORT:

Mark Forrest stated thirty-six (36) calls were responded to since having our paid EMS crew. Twenty (20) of these calls were billable. He said things are going okay. Some calls couldn't be answered-7 calls were lost and 3 calls were responded to by Norwich. No crew on one of the calls. It is working according to Mark Forrest. They are still challenged with staffing and wish to transfer a couple EMS people from Sherburne to come to Oxford. It is nice to see the ambulance around the village and the attendants in them.

CODE ENFORCEMENT:

There were several neighbors at the meeting today regarding problems stated previously in these minutes.

WWTP:

Brenton Rideout accepted the offer for the WWTP Operator position. He will start on November 15, 2021. There was no report from WWTP Operator Noetzel.

POLICE DEPARTMENT:

OIC Francis sent his monthly report.

DEPARTMENT OF PUBLIC WORKS:

Park Street Extension and Greene Street Project – We may see the work getting started by mid-September.

Resolutions were adopted as presented and approved by the Board. Resolutions are above.
